ADDENDUM TO MANAGEMENT CONSULTANT AGREEMENT

THIS ADDENDUM TO AGREEMENT ("Addendum to Agreement") is by and between Russell Township, Ohio, through its Board of Trustees ("Client"), whose administrative offices are located at 8501 Kinsman Road, P.O. Box 522, Russell Township, Novelty, Ohio 44072; and Clemans, Nelson & Associates, Inc. ("Consultant"), whose administrative offices are located at 485 Metro Pl S, Suite 200, Dublin, Ohio 43017.

NOW, THEREFORE, the Parties mutually agree as follows:

- 2. Section IX is expanded as follows:
 - <u>Discrimination</u>. Consultant or any subcontractor in the hiring of employees for the performance of services under this Agreement or any subcontract shall not by reason of race, color, religion, creed, sex, sexual orientation, gender identity, age, handicap, national origin, genetic information, military status, veterans status, or ancestry discriminate against any citizen of this state in the employment of a person qualified and available to perform the work to which the Agreement relates. Consultant or any subcontractor, or any person acting on behalf of Consultant or subcontractor shall not in any manner, discriminate against, intimidate, or retaliate against any employee hired for the performance of work under this agreement on account of race, color, religion, creed, sex, sexual orientation, gender identity, age, handicap, national origin, genetic information, military status veteran status, or ancestry.
- 3. The remaining provisions of the Agreement remain in effect, and Consultant hereby renews its representations and certifications therein, incorporated herein by reference.
