The Department's In-Car video system was installed in 2007, this was a Geauga County purchase, county wide, from the 911 tax monies that did not require funding for the current cameras and hard-drives from the Russell Police Department.

The system is a Panasonic Arbitrator brand, and has proved for the past 11 years to be robust equipment. The current equipment is obsolete and parts are no longer available should there be a breakdown, also there is no longer any technical support for the system due to age.

The In-Car Camera System is used on a daily basis by Officers during their interaction with the public, and rear seat recording for transports and in-custody persons. This has become standard equipment in law enforcement.

Video and audio are recorded during police interaction and automatically recorded when the police vehicle triggers certain actions, Ex: Over- head lights in the on position, high vehicle speed, quick braking.

When a cruiser pulls into the station the video and audio data are automatically downloaded / transferred onto our server at the Police Department through an Access Point located in the Police Department Garage.

The system is in the 5 marked Police vehicles, and would replace the obsolete equipment.

This is part of the Department's 5 year planning.



- For out of warranty units, the customer must ship the unit pre-paid to the NSC. The unit is tested and an estimate will be provided, normally within two days. Upon acceptance of the estimate, the unit is repaired and returned. The customer is responsible for all costs, including labor, parts, and shipping.
