Mr. MUELLER moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said ³ Township of Russell, Geauga County, Ohio; therefore be it

RESOLVED, by the ² Board of Trustees of the Township of Russell, Geauga County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of Russell Township (Name of Subdivision)

for the purpose of ⁴ the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges in Russell Township as provided in O.R.C. 5705.19(G).

at a rate not exceeding 1.40 mills for each one dollar of valuation, which amounts to fourteen cents (\$0.14) (Here insert rate expressed in dollars and cents)

for each one hundred dollars of valuation, for ⁵ a continuing period which levy is an additional tax of 1.40 mills.




